



Society for Cardiovascular Magnetic Resonance Website Terms & Conditions

Effective Date: March 26th, 2026

These Terms & Conditions (“Terms”) govern your access to and use of the websites located at www.scmr.org, www.heartmri.org, www.scmr.site-ym.com/general, <https://scmr.peachnewmedia.com/store/provider/provider09.php>, or related properties (together, the “Site”) operated by Society for Cardiovascular Magnetic Resonance (“SCMR,” “us,” “our,” or “we”).

Please be aware that these Terms constitute a binding legal agreement between you and SCMR. By accessing or using the pages in our Site, you agree to be bound by these Terms. You also agree that you are responsible for your use of our Site and any resulting consequences. If you do not agree, you should not use the Site.

OWNERSHIP

The Site is owned, operated, and maintained by SCMR. Our Site and all perceptible components hereof, including without limitation, information, graphics, pictures, buttons, text, images, layout, arrangement, audio, and other material (collectively “Content”) are copyrighted by SCMR. SCMR makes no representation that the Content of our Site is equally available to members and non-members or that non-members can access all aspects of our Site.

ELIGIBILITY

These Terms apply to all visitors, users, and others who access or use the Site. GOVERNING LAW & JURISDICTION

These Terms shall be governed by and construed in accordance with the laws of the State of Illinois, without regard to its conflict of law provisions. You agree that any legal action or proceeding arising under these Terms will be brought exclusively in the Northern District of Illinois or state courts located in Kane County, Illinois, and you consent to personal jurisdiction and venue therein.

CHANGES TO TERMS

We may modify these Terms at any time, and such modifications shall be effective immediately upon posting of the modified Terms. The “Effective Date” at the top will reflect when the current version was posted. You agree to review the Terms periodically to be aware of such modifications. Your continued access or use of our Site shall be deemed your conclusive acceptance of the modified Terms. If you do not agree, you must stop using our Site.
